**ARTICLE 3 - QUALIFICATION OF MEMBERS**

(A) NO PERSON UNDER THE AGE OF EIGHTEEN (18) YEARS SHALL BE ADMITTED TO MEMBERSHIP OF CLUB  
(B) THE QUALIFICATION OF ORDINARY MEMBERSHIP SHALL BE THAT THEY ARE PERSONS WHO AT THE DATE OF ELECTION TO MEMBERSHIP ARE:

- (I) PLAYERS OF RUGBY LEAGUE FOOTBALL; OR
- (II) PERSONS WHO HAVE BEEN PLAYERS OF RUGBY LEAGUE; OR
- (III) PERSONS WHO ARE HOLDERS OF OFFICIAL POSITIONS IN ANY ORGANISATION OR CLUB CONTROLLING THE PLAYING OF RUGBY LEAGUE FOOTBALL; OR
- (IV) PERSONS WHO HAVE PREVIOUSLY HELD SUCH POSITIONS AS ARE REFERRED TO IN THE PREVIOUS PARAGRAPH; OR
- (V) PERSONS WHO SATISFY THE DIRECTORS THAT BY REASON OF CONSISTENT ATTENDANCE AT RUGBY LEAGUE MATCHES OR PERSONAL EFFORT IN RELATION TO THE ORGANISATION COACHING MANAGING OR OTHERWISE CARRYING OUT WORK OR DUTIES IN RELATION TO THE PLAYING OF RUGBY LEAGUE (WHETHER BY TEAMS OF THE CLUB OR NOT) THEY SHOULD BE REGARDED AS GIVING SUBSTANTIAL SUPPORT TO RUGBY LEAGUE.
- (VI) SUCH OTHER PERSONS WHO MAY MAKE APPLICATION IN ACCORDANCE WITH THESE ARTICLES FOR ORDINARY MEMBERSHIP OF THE CLUB AND WHO IN THE OPINION OF THE BOARD ARE SUITABLE TO BE ADMITTED AS ORDINARY MEMBERS OF THE CLUB
