**NOTICE TO MEMBERS REGARDING PROPOSED AMALGAMATION WITH
ABERDEEN R S L & CITIZENS’ CLUB LIMITED ACN 001 065 363**

Pursuant to Section 17AE of the *Registered Clubs Act* and clause 4(5) of the *Registered Clubs Regulation 2015*, the members of Cabramatta Rugby League Club Ltd ACN 000 650 206 (“**Cabramatta Leagues Club**”) are hereby notified that:

1. Aberdeen R S L & Citizens’ Club Limited ACN 001 065 363 (“**Aberdeen RSL**”) called for expressions of interest in amalgamation on 2 August 2022.
2. Cabramatta Leagues Club responded to Aberdeen RSL’s call for expressions of interest in amalgamation and Aberdeen RSL has advised Cabramatta Leagues Club that it has decided to enter into an amalgamation with Cabramatta Leagues Club subject to execution of a Memorandum of Understanding and member approval.
3. Cabramatta Leagues Club will be the continuing club in the amalgamation and Aberdeen RSL will be the dissolving club in the amalgamation. Cabramatta Leagues Club and Aberdeen RSL will shortly enter a Memorandum of Understanding containing the terms of the proposed amalgamation.
4. A copy of the Memorandum of Understanding once entered will be made available to members of Cabramatta Leagues Club for inspection on the Club’s premises at reception and on Cabramatta Leagues Club’s website at least twenty-one (21) days before the General Meeting at which members will vote on the proposed amalgamation.
5. After the Memorandum of Understanding is executed, Cabramatta Leagues Club and Aberdeen RSL will convene separate general meetings for members of each club to vote on the proposed amalgamation. A Notice of General Meeting will be sent to members of Cabramatta Leagues Club at least twenty (21) days before the General Meeting.
6. If the proposed amalgamation can be completed after various requirements have been met, then in substance all land, assets, liabilities and the club licence of Aberdeen RSL, as set out in the Memorandum of Understanding, will pass to Cabramatta Leagues Club subject to the terms and conditions of the Memorandum of Understanding.
7. During the twelve (12) month period immediately preceding the date of this notice, Cabramatta Leagues Club can advise that it has received two (2) other expressions of interest in amalgamation or unsolicited merger offers being from the Hungarian (Magyar) Social Club Ltd and Aberdeen Bowling Club Ltd. The Club has recently entered an MOU with Aberdeen Bowling Club Ltd in relation to amalgamation and will hold a General Meeting for members to vote on that proposed amalgamation as well.
8. As required by clause 5 of the *Registered Clubs Regulation 2015* this Notice will be displayed on the Club’s Noticeboard and published on the Club’s website.
